: ALLOCATION OF CREDITS TO LOCAL WATER DISTRICTS

The Government Service Insurance System (GSIS) is now ready to allocate the P 64.583 M contributions that was transferred by SSS and deposited in escrow by GSIS some 20 years ago.

To facilitate posting of credits to individual members, GSIS urgently requests that concerned water districts (per attached listing) shall submit to the nearest local GSIS Branch Office, the following documents that will be the basis for the creation of the Members' Service Profile (MSP) on or before April 10, 2015:

- 1. Master list of <u>all employees (active, resigned or separated from service, retired, deceased)</u> for the service period June 1978 to March 1992;
- 2. Their individual service records (SRs);
- 3. List of <u>all</u> employees with outstanding loan accounts/balances with SSS including the amount involved, if any;

Should there be difficulties in retrieving the above records or data, the Water District is requested to <u>fully disclose</u> the circumstances/reasons behind the same.

Attached, is the list of "Local Water Districts with Credit Allocation (CA) from SSS" showing the amount of credits in favor of each water district. The minutes of the meeting between representatives from PAWD and the GSIS dated March 10, 2015 is also attached for your information and guidance.

- 4. GSIS will issue an advisory to GSIS Branch Offices to accept the documents that the LWDs will submit to them.
- 5. The procedures in processing the CA of the LWDs will be issued by the NCR Operations Group.
- 6. Deadline for the LWDs to submit the required documents will be on April 10, 2015.
