- 13. That the CONSUMER agrees to pay the minimum charge even if he will not use his water service connection, as long as the District record, his service connection is still active. The CONSUMER has no right to disconnect his water service connection/water meter and use it as a ground for not paying his monthly water bill. The CONSUMER also has the right to request for temporary Cut-Off if he wish not to use his Water Service Connection or for whatever reason, but upon reconnection of the service he has to pay the arrears and reconnection fee.
- 14. That the CONSUMER authorizes the DISTRICT to replace the water meter anytime or without CONSUMER'S consent for recalibration purposes and as the need arises.
- 15. That the CONSUMER authorizes the DISTRICT to install the water meter outside their premises or three (3) meters away from the tapping point.
- 16. That the CONSUMER agrees and understands that in case of delinquency in payment of dues, his/her service connection can be disconnected by way of removing his/her water meter, by the DISTRICT even in his/her absence.
- 17. The CONSUMER shall forfeit his right over the tapping if he fails to reopen/reactivate his water service connection after one year from the time it was cut-off, and he shall re-apply as new concessionaire and subject to payment of the installation fee.
- 18. The CONSUMER agrees to allow properly authorized employee or representative of the DISTRICT to enter his/her premises at a reasonable time for the purpose of determining and removing illegal connection, reading, delivering water bills, testing, replacing water meters, and removing the properties and equipment of the DISTRICT in the event of termination of this agreement for any cause and/or even after the water connection had been cut-off for the purpose of protecting the interest of the DISTRICT.
- 19. The CONSUMER finally agrees to limit his/her service connection to one family. If the CONSUMER is not the owner of the house, building or premises where connections is desired, the application and this agreement must be likewise signed by the property owner who shall guarantee the payments of all sums in case of the default of the CONSUMER.
- 20. The CONSUMER agrees to follow DISTRICT Rules and Regulations, policies and other directive as may be formulated, amended and enforced from time to time.
- 21. The property owner agrees to guarantee/ assume responsibility of payments of all water bills and all accounts incurred in connection with the said services upon the default of payment of the above CONSUMER.
